A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS SUPPORTING THE CITY OF BASTROP'S APPLICATION(S) FOR THREE TRANSPORTATION ALTERNATIVE GRANTS AS FOLLOWS: THE OLD IRON BRIDGE REHABILITATION, THE FARM AND CHESTNUT LOOP, AND THE WILSON AND WILLOW SHARED LOOP, TO THE TEXAS DEPARTMENT OF TRANSPORTATION'S 2021 TRANSPORTATION ALTERNATIVES CALL FOR PROJECTS, PROVIDING FOR A REPEALING CLAUSE: AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Bastrop City Council values all forms of transportation and understands the worth multi-modal transportation brings to the citizens of Bastrop; and,

WHEREAS, the City of Bastrop intends to submit a transportation alternatives project application for the Old Iron Bridge rehabilitation, the Farm and Chestnut loop, and the Wilson and Willow shared loop, to the Texas Department of Transportation's 2021 transportation alternatives call for projects; and,

WHEREAS, the City of Bastrop intends to submit a Transportation Alternatives project application for the Old Iron Bridge rehabilitation, the Farm and Chestnut loop, and the Wilson and Willow shared loop; and,

WHEREAS, the Texas Department of Transportation requires the submittal of a resolution as part of the Transportation Alternatives Call for Projects application submission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

- **Section 1:** The recitals set forth above are true and correct and are incorporated as if fully set forth herein.
- <u>Section 2:</u> The City of Bastrop supports the construction of the Old Iron Bridge rehabilitation, the Farm and Chestnut loop, and the Wilson and Willow shared loop.
- <u>Section 3:</u> The City of Bastrop will serve as the Project Sponsor and lead project contact on this project. The Town of Addison agrees to designate a single point of contact for the project.
- **Section 4:** The City of Bastrop commits to fund or pass-through funds from other sources for a minimum local match of 20% of the construction costs.
 - **Section 5:** That this Resolution shall take effect immediately upon its passage.
