

RESOLUTION R-2025-102

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, APPOINTING A CITY COUNCIL MEMBER TO SERVE AS THE CITY OF BASTROP'S AT-LARGE GENERAL ASSEMBLY REPRESENTATIVE AND DESIGNATING ONE NOMINEE TO SERVE AS THE CITY'S EXECUTIVE COMMITTEE REPRESENTATIVE ON THE CAPITAL AREA COUNCIL OF GOVERNMENTS (CAPCOG); REPLACING CURRENT REPRESENTATIVES LYLE NELSON AND SYLVIA CARRILLO-TREVINO; AUTHORIZING THE MAYOR TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING FOR A REPEALING CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Bastrop, Texas is a member of the Capital Area Council of Governments (CAPCOG); and

WHEREAS, CAPCOG is composed of official representatives including cities, counties, school districts, chambers of commerce, non-profit agencies and other agencies that have an interest in regionalism and programs such as emergency communications, homeland security, planning and economic development, law enforcement, and air quality; and

WHEREAS, City Council nominations represent the City of Bastrop on the CAPCOG Clean Air Coalition and the community benefits by active participation in the CAPCOG and regionalism;

WHEREAS, the City Council designates Kerry Fossler and Gary Blake to be the General Assembly Representative to CAPCOG.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:


