- 6. Items for individual consideration and discussion.
 - a. Discuss and consider action regarding Sticks Creative contract for FY 2020 for marketing services. Discussion to find a person to be the liaison with Katie to facilitate updates. A motion was made by Billy and seconded by Dick to allocate for the month of November \$830 with Sticks.
