## MINUTES OF SPECIAL MEETING City of Bastrop Board of Ethics

### Monday, April 11, 2022

Pursuant to the Texas Government Code, Chapter 551, the City of Bastrop Board of Ethics met in a Special Meeting on Monday, April 11, 2022, at 1:12 p.m. at the Bastrop City Hall, 1311 Chestnut Street, Bastrop Texas. #### CALL TO ORDER

At 1:12 p.m. Commissioner Duggan called the meeting to order with a quorum present.

## APPROVAL OF MINUTES

- 3A. Consideration and discussion of complaint filed by Mayor Connie Schroeder on March 25, 2022, determination as to whether the complaint shall be deemed actionable or baseless, and related procedural issues. Judge Duggan confirmed status on the panel in order to satisfy the ordinance's definition of "panel". The Code definition of panel requires at least an attorney or retired judge. As Chair, Judge Duggan assigned himself to the panel. The Chair excused Barbara Caldwell from the panel. The panel consists of Judge Chris Duggan, Pastor Bob Long, and Corporal Wuthipong Tantaksinanukij.

3A. Consideration and discussion of complaint filed by Mayor Connie Schroeder on March 25, 2022, determination as to whether the complaint shall be deemed actionable or baseless, and related procedural issues.

A motion was made by Bob Long, seconded by Wuthipong Tantaksinanukij, the motion was as follows. Regarding prohibition on representing others, the panel deemed the complaint ACTIONABLE because facts alleged, if taken as true, indicate a violation of 1.15.009(d)(1) to wit: while a city official, the accused represented others before the city, including the Historic Landmark Commission and City staff. The motion passed on a 2-0-1 vote. Chair Duggan abstained.

A motion was made by Wuthipong Tantaksinanukij, seconded by Bob Long, the motion was as follows. Regarding improper influence, the panel deemed the complaint ACTIONABLE because facts alleged, if taken as true, indicate a violation of 1.15.009(e)(1) to wit: while a city official, accused attempted to secure a benefit for his private client in the form of a deviation from city protocols. The motion passed on a 2-0-1 vote. Chair Duggan abstained.
