#### **BACKGROUND/HISTORY:**

As part of the FY2018 budget, a ground-truthing and GPR project was approved for a portion of the "west" section of Fairview Cemetery. The area is known to contain unmarked graves and as a result, plots are no longer sold in this area. However, heirs continue to request burials of family members in family plots passed down by generations. As a result, burials allowed to commence are at risk of accidental disinterment. Our goal is to alleviate some risk and identify where burials have occurred and mark those with memorials. The intent of this project is to identify unmarked graves.



### What is GPR?

GPR is Ground Penetrating Radar. AmaTerra will deploy an antenna connected to a data collector and survey cart. AmaTerra will collect GPR profiles and compile the profiles into time slices/plan views using RADAN GPR data processing software. Soils in the study area are prevalently sandy loams over clay loam; and GPR signatures of subsurface features such as unmarked interments are expected to show strongly in the soil column. The ability to conduct trial passes over known graves of similar antiquity within the cemetery may also substantially improve the resulting data. During the course of the study, if the GPR operator identifies subsurface profiles that are consistent with those of an unmarked grave, they will be identified with a pin flag(s). AmaTerra assumes that the GPR survey will require approximately two to three days to complete.



(Above is a profile from work at Mother Neff State Park near Waco. This shows what the GPR profile looks like on the screen and after it's outputted onto a computer.)

The GPR equipment, shown at right, consists of two main parts: the orange box is the antenna. At one end of the box is the radar emitter and at the other end is the receiver. The antenna sends radar pulses into the ground that bounce off whatever is below and those pulses come back to the receiver. The time it takes a pulse to come back and the strength of that returning pulse are interpreted with the data collector (the gray tablet-looking thing with the blue sun shade). The data collector is a mini-computer that sets up the various equipment settings, controls the antenna, and collects the data. There's a display on the screen that shows the soil profile in real time as you push the cart along.

The cart is pretty common to use, although not required, and AmaTerra does plan to utilize it for our project. A GPS antenna on the equipment can obtain super-accurate location readings as well but was not used in the survey shown.



### What is Ground Truthing?

<u>Ground truthing is a process.</u> In the field, AmaTerra will deploy a backhoe or Gradall with a minimum 3-foot wide, flat-bladed bucket to conduct a series of scrapes to identify evidence of unmarked burials.

All scraped areas will be mapped using a hand-held GPS device with sub-meter accuracy. The field team will further document each trench on a standardized form and through photographs, recording the location and depth of any features within. In the event that any scraped area extends deeper than 3 feet, it will be staked off and marked with yellow caution tape.

All scraped areas and trenches will be backfilled at the end of the project. As with the remote sensing survey, the location recorded soil stains or materials indicating graves will be marked with pin flags and ultimately mapped with a sub-meter accuracy GPS. Any human remains inadvertently exposed will be carefully documented and mapped but will not be excavated. Investigators will notify the City of Bastrop and the other consulting parties, and then completely re-cover remains.

A Gradall is shown to the right but it is more likely that a smooth-bucket, standard backhoe would be used. Whatever equipment is utilized, scraping will be done – not digging.



# What are the Advantages & Disadvantages of Ground-Truthing & GPR?

### **GROUND-TRUTHING: SCRAPING/FORMAL EXCAVATION**

- Advantages: Almost fool-proof and, if properly done, will provide a definitive answer. Can be performed in any soil type, rocks are not a problem. If other methods will require ground-truthing, scraping first will be a cost savings.
- <u>Disadvantages</u>: Invasive, so families may object. Expensive; it requires an archeologist and machinery. There is always a chance that a very ephemeral burial will be missed and destroyed by machinery, although this is highly unlikely.

### **GROUND-PENETRATING RADAR (GPR)**

- Advantages: GPR is non-invasive, so families typically do not object. Under ideal conditions, it can
  provide a highly-detailed image of the subsurface. GPR is probably the best form of remote sensing
  if the clay content of the soil is low and the surface conditions are favorable.
- <u>Disadvantages</u>: GPR's effectiveness depends greatly on soil conditions; it does not work well in clay-rich, rocky, or saturated soils. Success also depends on surface conditions and vegetation. GPR often requires some form of ground-truthing.

AmaTerra is a small, minority-owned, and Historically Underutilized Business (HUB) and Disadvantaged Business Enterprise (DBE).

### What Were the Alternate Methods **Not** Chosen?

There are advantages and disadvantages to each method. It is important to remember that no method is foolproof in finding unmarked graves. Some of the other methods are:

### Rod Probing

 Disadvantages: Invasive and some families may object. Not typically useful for burials in wooden coffins that have likely deteriorated over the years. Rocks and other solid objects can give false readings.

### Soil Coring

 Disadvantages: Invasive and some families may object. Requires an archaeologist or soils scientist. Difficult or impossible in rocky soil. Soil differences can be so subtle so that it cannot be determined if a grave exists. May require ground-truthing or scraping.

### Resisitivity

 Based on principles of soil moisture retention and electricity conduction. Ineffective if upper level of soil is disturbed and very wet/dry conditions. Can be expensive. Difficult in rocky soil. May require ground-truthing or scraping.

### Conductivity

o Ineffective if the upper level of soil is disturbed over a large area. It is ineffective in the presence of ferrous metal, so the survey area has to be very clean and checked with metal detectors. It can be less effective if the soil is saturated, very dry, or rocky. It is affected by nearby power lines. May require ground-truthing.

### Magnetometry

o Ineffective if the upper level of soil is disturbed over a large area. Soils need to have significant iron oxide content. Ineffective in the presence of ferrous metal (iron, steel, etc.), so the survey area has to be very clean and checked with metal detectors. Magnetometry can be expensive. May require ground-truthing.


### Dowsing/Witching


Most agree that dowsing is no better at finding graves than common-sense intuition. Dowsing could put the

### SCHEDULE OF WORK

### Fairview Cemetery Advisory Board

- The <u>City</u> acts as the permanent trustee for the perpetual care and upkeep of plots and graves in the cemetery.
- The <u>Fairview Cemetery Advisory Board</u> recommends rules to the City Council concerning the use, care, control, management, restriction, and protection of the Fairview Cemetery.
- The Board also advises City Council on any issues it determines are necessary to the proper conduct of cemetery business and for the protection of the principles, plans, and ideals by which the Fairview Cemetery is to be operated.
- The Fairview Cemetery Board meets quarterly, or on a more frequent based as needed.

### 2017 Accomplishments

- **ORDINANCE**: Completed an extensive review of the cemetery ordinance and made recommendations to the City Council, which simplified the ordinance and narrowed restrictions to those primarily involving public safety and/or maintenance.
- TREES: Identified concerns surrounding the aging of existing trees and the need for additional and replacement trees to retain the Fairview Cemetery's beauty for future generations.
- <u>MEMORIAL TREE PROGRAM</u>: Instructed staff to draft suggested guidelines for the implementation of a Memorial Tree Program after being made aware of requests from citizens to plant trees in memory of their loved ones.

Heirs of those buried at Fairview Cemetery place a priority on being able to personalize their loved ones' graves.

The revised Cemetery Ordinance was intended to balance safety, maintenance, and the wishes of the heirs and friends.



### 2017 Cemetery Ordinance Revisions







### Significant Ordinance Revisions in 2017

The Fairview Cemetery Advisory Board met on October 19, 2016, to review and recommend approval of changes to Chapter 15 "Fairview Cemetery" of the Code of Ordinances of the City of Bastrop. Most of the changes were essentially administrative clarifications. Rationale for significant changes include:

- <u>Section 15.01.015</u>. <u>Prohibited Activities</u>: Several revisions and deletions were made to this section. The intent was to provide opportunities for property owners in all sections of the cemetery to honor their loved ones in an equal manner (i.e. curbing). In addition, the focus on prohibited activities was shifted to place the emphasis on activities that are hazardous or dangerous to the environment, public, or City employees.
- <u>Sec. 15.01.016 Monument, memorial or tombstones; construction permit required.</u> In the past, variances had been approved for requests related to two parts of this section. Therefore, the revised ordinance removes the prohibition against mausoleums and increases the height allowed for monuments to 6' in height or less from the previous 4' maximum.
- <u>Sec. 15.01.017 Placement of objects in the Fairview Cemetery.</u> The Fairview Cemetery Board and City Council previously indicated that they prefer that plot owners have the ability to honor loved ones at rest in Fairview Cemetery in a personal manner. Revisions and additions to this section are intended to allow the personalization of plots, provided that they are maintained by the property owner or heirs. Many previously prohibited items such as ground coverings, long-term holiday decorations, benches, and flags larger than 12" are now permitted.
- <u>Sec. 15.01.018 Planting in the Fairview Cemetery.</u> Revisions in this section are intended to allow some planting on plots provided the plot owners maintain the growth per the ordinance. (Note: The planting of trees is still not permitted.)

OBJECTIVE DESCRIPTION: To determine the fee that needs to be charged and the amount of that fee that should be allocated to the permanent care fund to cover the perpetual maintenance of the Cemetery in the long-term future.

### Perpetual Care Language

### Sec. 15.01.003 - Adoption and enforcement of rules and regulations to establish perpetual care cemetery and protect and care for graves.

- (a) The city shall adopt and provide for the enforcement of such reasonable rules and regulations as may be necessary to establish, maintain, and oversee the Fairview Cemetery as a perpetual care cemetery, to protect the graves of those who are interred in the cemetery, and to maintain the beautification of the cemetery under uniform conditions. Perpetual care shall herein mean a cemetery for the benefit of which is created a perpetual care trust fund established pursuant to state law for the maintenance, repair and care of all plots and graves in the cemetery including, but not limited to road maintenance, mowing, edging, pruning, landscape construction, pest control, security, and all other maintenance activities that are deemed necessary to the care, protection, and preservation of the cemetery.
- (b) The city is hereby empowered to enforce all rules and regulations, to exclude from cemetery property any violator and shall have charge and supervision of the grounds, buildings, persons on cemetery property, funerals, traffic, employees, plot owners and invitees.

### Cemetery Plot Fees

Sec. A15.01.012 - Sale of cemetery plots; generally.

#### Cos

- (1) Cost to purchase one (1) cemetery plot:
  - (a) Residents of the City of Bastrop: \$1,000.00, of which 100% shall be deposited into the Operating Fund\*.
  - (b) Non-residents of the City of Bastrop: \$1,500.00, of which 100% shall be deposited into the Operating Fund\*.
- (2) Unchanged.
- (3) Permit fee: \$25.00\*

(Ord. No. 2012-15, 8-28-12; Ord. No. 2014-7, 5-13-14; Ord. No. 2015-13, pt. 1, 9-8-15)

The City's Cemetery Ordinance establishes Fairview as a perpetual care cemetery but the fees currently being charged are deposited directly into the Operating Fund.


Perpetual care includes maintenance, repair and care of all plots and graves. Because Fairview is a perpetual care cemetery, it is critical to determine what level and type of fees are needed to maintain the cemetery's future needs.

Thomas Longoria, PhD, Texas State University, will be working with staff on a report in Spring 2018.

Maintenance is under the supervision of the Parks Superintendent with one main dedicated employee.








The Fairview Cemetery budget has an operating fund supported by lot sales, and a permanent fund that results from the transfer from the former cemetery association to the City of Bastrop.

OBJECTIVE DESCRIPTION: To determine the graves in this west section of the cemetery that are occupied (but not marked in records) or not occupied and can be changed to available to be sold (potentially).



### What You See Can't Always Be Trusted!



In cemeteries, what you see on the surface does not always reflect what is below. For instance:

Grave markers can be at the head, foot, or center of a grave, or can be some distance from the grave.

Burials can be oriented in any direction relative to a marker or nearby burials.
The markings on the grave marker may face towards or away from the burial.
Multiple individuals may be buried under one marker.
Burials may lack markers, perhaps due to cultural traditions, deterioration of original grave marker material, or desecration.

Markers may also be situated over empty graves.

If there is a depression, it may be larger or smaller than expected. Depressions do not always indicate graves, since cemetery workers can borrow soil from one area to fill in low spots in another, creating depressions that may resemble graves.

It is not a safe assumption, therefore, that surface conditions indicate what may or may not be below the surface. Where records are inadequate, some sort of remote sensing or subsurface testing is needed to locate burials. The most common techniques are described below.

### West Section Background Information

Through "ground-truthing" and ground penetrating radar (GPR), the City of Bastrop hopes to locate burials in the K and L sections of Fairview Cemetery. If successful, additional sections may be undertaken in phases as budgeting permits.

### **HISTORY**

The City of Bastrop acquired Fairview Cemetery in 2005. Formerly, records were maintained on paper lacking in adequate detail. As a result, the City has concerns about the farthest west sections that may contain burials not visually obvious or through available records. Long-time Bastrop citizens recount how burials from the "poor house" and "black" community were simply buried there with no recordation for future records, or with any logical layout.

The entire west section of Fairview, formerly known as the "black section", is an area divided into two parts measuring 90' x 650' and 123' x 575' and divided into sections "A-L". These areas are the resting place of mainly Blacks and Latinos. The area is known to contain unmarked graves.

The City has incomplete knowledge of where burials have taken place and plots are no longer sold in this area. However, heirs continue to request burials of family members in family plots passed down by generations. As a result, burials allowed to commence are at risk of accidental disinterment. Our goal is to alleviate some risk and identify where burials have occurred and mark those with memorials.


### Examples of West Section Map Records




These are actual scanned copies of the West Section K & L maps that staff use to locate graves and identify plots for burial in the area.

The graves are hand-drawn onto the maps that are not drawn to scale. Since these have been recorded by hand, staff are always concerned about the accuracy of ownership and burial records in the area.

Clearly there is a real possibility of human error resulting in accidental disinterment any time a grave is opened.



**Signage** (similar to graphic on below right) will be placed along Indian Paintbrush as well as at intersections in the vicinity of the project area.



PUBLIC NOTICE: This is an archeological investigation, known as GPR and Ground Truthing, being conducted at the request of the City of Bastrop to find the locations of unmarked burials. This work will be as non-invasive as possible using ground penetrating radar followed by shallow scraping to expose the tops of burial shafts only. No actual burials are intended to be exposed or damaged.



OBJECTIVE DESCRIPTION: To allow families to memorialize their loved ones at the same time controlling the types of trees and placement in the cemetery.

### TREES

Beautiful, aging, and historic trees make a replacement plan critical to maintaining the future beauty of Fairview Cemetery.

In addition, there are areas of the Cemetery in need of shaded areas for visitors to reflect and grieve comfortably. Two tree species have been selected. More tree options are available through the Memorial Program.



### TEXAS ASH Fraxinus texensis

The **Texas Ash** is a tree recommended for replacement of generally aging trees and for addition of new trees in areas where few trees are currently located.

The Texas Ash is a smaller yet faster growing tree well suited for Central Texas.

The Texas Ash is also considered a "Firewise" tree for landscaping for reducing wildfire risks.

- Tree Description: A medium-sized tree to 45 feet tall and a trunk to 2 feet in diameter, with an oval crown.
- <u>Flower</u>: Male and female flowers borne on separate trees. Female flowers in loose clusters appearing with the new leaves; male flowers appear as dark, purplish clusters near the end of the twigs, often before the leaves.
- <u>Bark</u>: Gray, with brown or black blotches, furrowed, with the interlocking flattened ridges common to the ashes on older trunks.


### Escarpment Live Oak *Quercus fusiformis*

This tree is also recommended for replacement of generally aging trees and for addition of new trees in areas where few trees are currently located.

The Escarpment Live Oak is a larger but slower growing tree that is drought and cold tolerant. Live Oaks are also considered "Firewise" trees for landscaping for reducing wildfire risks.

- Tree Description: Height: 20 to 50 ft., width: 25 to 40 ft.
- <u>Character</u>: Is an evergreen/semi-evergreen tree adaptable to most soils and full sun exposure.
- Fruit and Flower: elongated acorn; green catkins




