A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS, APPROVING AN AMENDMENT TO TASK ORDER NO. BAS.006A TO KSA ENGINEERS FOR ADDITIONAL ENGINEERING DESIGN SERVICES TO INCLUDE A NEW WATER LINE AND DIESEL ENGINE GENERATOR (IN LIEU OF GAS ENGINE GENERATOR) IN THE AMOUNT OF TWO HUNDRED FIFTY-FIVE THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS (\$255,500.00) AS ATTACHED IN EXHIBIT A, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS; PROVIDING FOR A REPEALING CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Bastrop, Texas has appointed the City Manager as the Chief Administrative Officer of the City; and

WHEREAS, the City Manager is responsible for the proper administration of all affairs of the City; and

WHEREAS, the projected growth of the City of Bastrop will soon result in wastewater flow rates that will exceed the capacity of the City's current wastewater collection system and treatment facilities; and

WHEREAS, the City Council of the City of Bastrop, Texas has the vision to improve Bastrop's Community Safety by building Wastewater Treatment Plant No. 3; and

WHEREAS, engaging KSA Engineers to provide design and construction management services for Wastewater Treatment Plant No. 3 meets that intent and is Item CS#15 in the City's Work plan; and

WHEREAS, the City of Bastrop has chosen KSA Engineers from a list of qualified consulting firms identified by City Council on July 10, 2018; and

WHEREAS, the City Council of the City of Bastrop, Texas approved a contract for the design of Wastewater Treatment Plant #3 and related collection system improvements on August 28, 2018; and

WHEREAS, the Amendment to Talk Order No. BAS.006A provides a cost saving for the overall project and future cost savings annually.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BASTROP, TEXAS:

<u>Section 1:</u> The City Manager is hereby authorized to execute the Amendment to Task Order No. BAS.006A for to KSA Engineers in the amount of Two Hundred Fifty-five Thousand Five Hundred Dollars and Zero Cents (\$255,500.00) as attached in Exhibit A.

<u>Section 2:</u> The City Council of the City of Bastrop has found KSA Engineers to be a subject matter expert in the field of Wastewater Treatment Plants.

2. Description of Modifications

- Engineer shall perform the following Additional Services:
 Based upon the results of the Value Engineering Study, the Engineer will:
 - 1. Redesign the plant standby power facilities to include diesel generator(s) in lieu of natural gas generators as previously requested by the City. This revision is estimated to provide a construction cost savings of \$500,000.
 - 2. Provide design and construction phase services for a 8,600 LF of new 12-inch water line that will extend from State Hwy 304 near Hunters Point Drive to WWTP No. 3 (see attached exhibit). This line will service the treatment plant and provide a future tie-in point for water service to customers on the east side of the Colorado River. The Predesign Opinion of Probable Construction Cost for the line is \$900,000.
- b. The Scope of Services currently authorized to be performed by Engineer in accordance with the Task Order and previous amendments, if any, is modified as follows: N/A
- c. The responsibilities of Owner with respect to the Task Order are modified as follows: Water Model will be built based on static water distribution system pressure from the Hunters Point Drive subdivision, if available. The water distribution system model will be built for the new water line segment only, unless an existing water distribution system model exists for Hunters Point Drive subdivision, in which case, a copy of the model will be required from 3rd party consultant.
- d. For the Additional Services or the modifications to services set forth above, Owner shall pay Engineer the following additional or modified compensation:


