		GENERAL NOTES:		
		⇒ No person shall act as a Mobile Food Vendor in the City without a permit issued by the City. ⇒ Mobile Food Vendors must meet all applicable state and local laws and regulations, including but not limited to the Rules. ⇒ Each Mobile Food Vendor shall display at all times in a conspicuous place where it can be read by the general public: <ul style="list-style-type: none"> ○ the City of Bastrop permit under this article and permit number. ○ a health permit from Bastrop County. ○ a copy of a Texas sales tax and use certificate. 		

		<p>⇒ Mobile Food Vehicles must be movable by motorized or non-motorized means.</p> <p>⇒ Mobile Food Vending Units cannot obstruct driveways or fire lanes.</p> <p>⇒ Mobile Food Vehicles must be movable by motorized or non-motorized means.</p> <p>⇒ Two sandwich board signs may be used on-site during business hours. All other signage must be on the truck or trailer and mounted flush to the surface of the unit.</p> <p>⇒ Mobile Food Vending Units (Truck, Trailer or Concession Cart) must be movable by motorized or non-motorized means.</p> <p>⇒ Any Mobile Food Vendor that will be in one location for more than four (4) hours shall provide covered garbage and storage facilities for employee and customer use of sufficient size that refuse is fully contained in a manner that prevents litter and remains insect- and rodent-proof.</p> <p>⇒ See Ordinance 2020-02 for additional code requirements.</p>

	2	Signed Application.		
	3	Application Review Fee.		
	4	Signed and notarized permission from all private property owners where the Mobile Food Vending Unit will be stationed.		
	5	Proof of motor vehicle insurance for each vehicle to be used in the mobile food vending operation.		
	6	An itinerary of locations where sales will occur; and a location map and sketch of site location for each location to be used by the Mobile Food Vendor.		
	7	A copy of the vendor's current health permit from Bastrop County.		
	8	Proof of water/wastewater service.		
	9	Documentation indicating the volume capacity of any required water and wastewater storage tanks either on the tank itself or in writing.		
	10	A notarized statement from the owner of the commissary stating that the mobile food establishment will use the facility as its base of operation and providing the address and food establishment permit number of the facility, OR retailer sources for food items to be cooked onsite or for resale.		
	11	A valid copy of the applicant's sales tax and use tax permit.		
	12	A copy of a valid government-issued identification document that includes photograph of applicant.		

	13	Copy Vehicle/Trailer/Unit License and Registration.		
	14	Any other information reasonably required by the Director of Planning and Development.		
	15	Digital submittals shall be provided via email to plan@cityofbastrop.org. Submit two documents: 1. Application - save as a .pdf and name: Mobile Food Vendor Permit Application - "Address" or "Project Name" 2. All Required Submittal Items - save as a .pdf and name: Mobile Food Vendor Submittal Items - "Address" or "Project Name"

	17.1	Certificate of Occupancy from Primary Business.		
	17.2	For a Mobile Food Vendor located on an existing site, a written agreement from a business within one hundred fifty (150) feet for employees of the mobile food establishment to have use of flushable restrooms during hours of operation.		
	17.3	Lot diagram showing the location of the Mobile Food Vending Unit and any temporary seating areas. (No permanent seating areas can be established. Temporary seating must be removed and stored daily within the Mobile Food Vendor or existing permanent structure may be allowed.)

	18.1	An itinerary of locations where sales will occur; and a location map and sketch of site location for each location to be used by the Mobile Food Vendor.		
	18.2	Approval by Director of Public Works for locations in city parks or properties.
