The Banquet will take place at the Doubletree by Hilton Austin on Thursday, February 2, 2023, commencing at 6:00 pm. Since before the City of Bastrop's Main Street Programs' inception in 2007, Ms. Nancy Wood has served Downtown Bastrop with a zealous dedication to community revitalization through community building. The idea of the City of Bastrop becoming a Texas Historical Commission Accredited Main Street was championed by a small, passionate group of volunteers, the Bastrop Downtown Business Alliance of which Ms. Nancy Wood was a member. She was hired on as Bastrop's first Main Street Manager in 2007 and humbly served the community until her retirement in 2015. Since that time, she has continued to volunteer at downtown events, mentor the Main Street Managers that served after her, and be a champion for small businesses. Today, Downtown Bastrop is a thriving destination hosting over 300,000 visitors a year and close to 200 businesses strong. Even while experiencing unprecedented growth, the City has retained its strong community feel as newcomers and current Bastropians have banded together to continue to love, honor, and protect our historic downtown. That fact has most recently been recognized by the Texas Municipal League through their Town & City magazine as well as Texas Highways Magazine. The success that Downtown Bastrop is experiencing today is because of the initiatives and traditions that Ms. Nancy Wood championed during her time as the Main Street Manager. Whether the project was investment in downtown infrastructure, or the hosting of a holiday parade that today hosts over 15,000 attendees, Ms. Nancy Wood continues to make a significant impact on Downtown Bastrop through the tenets of community revitalization.

#### **Diversity, Equity, and Inclusion Board**

The Diversity, Equity, and Inclusion Board had their first meeting on Monday, October 24, and is pending data from City staff, including the City Manager, to review before making a determination on future initiatives it will pursue.

#### **Ad Hoc Advisory Group**

An ad hoc advisory group composed of local developers met with the City Manager to discuss improvements to the B3 Code. The dialogue will continue through frequent meetings and a solution-oriented approach will be developed including both the customer and staff.

Military families, which includes two adults and any children that live in the household, may join the recreation center for \$40 (Resident) if they live in the City of Bastrop. Those living outside the city limits have a rate of \$45 (Non-Resident).

The center is located at 1008 Water Street. The building has quite a history with it being built in 1974 to serve as the public library. Since that time, the building has evolved and been used for many different purposes such as a Senior Center and now our very first Recreation Center.

Membership at the City of Bastrop Recreation Center is open to everyone. And with membership, everything is included. There are no extra fees. Opportunities offered at the recreation center include wellness, fitness, youth, senior and family programs. The center offers not only group exercise classes but also programs for youth development, healthy eating, and more. 

The Texas Municipal League has several motives in asking for your help on this survey. First, of course, is TML's concern for the financial well-being of Texas cities. By collecting and analyzing information on revenues and expenditures, we can best serve the interests of the cities in our advocacy efforts.

In addition, we use software applications that will enable us to look at data from different perspectives; for example, comparing population levels with types of revenues. The results of this analysis will help cities, legislators, and others understand the complexities of municipal government.

### **NLC Seeks Input to Improve 2030 Census**

The National League of Cities (NLC) is seeking input from cities on ways to reshape and improve the 2030 Census. The U.S. Census Bureau recently issued a <u>notice seeking input</u> from stakeholders on the development and implementation strategies that improve the way people participate in the 2030 Census. NLC will be providing comments to the Bureau on this topic and is currently collecting feedback from cities on the following issues: reaching and motivating people, technology, contacting and providing support to the public. A recent <u>NLC blog post</u> provides a more in-depth description of the issues the Bureau is hoping to solve. Cities may provide input to NLC here.
