## **March 22 Agenda Item**

On January 12, 2021 City Council approved the second reading of Ordinance No. 2020-34, amending the Code of Ordinances, affirming the creation of Assistant City Manager positions, addressing designation of an Acting City Manager, and removing the Director of Public Safety position by amending Sections 9.02.004 and 9.02.005, and repealing Article 9.05, Division 2. When the City went through a reorganization and removed the Director of Public Safety position, the ordinance should have been amended creating the Chief of Police position and removing the remaining references to the repealed Director of Public Safety position. This will be rectified on the March 22, 2022 Council Agenda.

## **Texas Parks and Wildlife Department Town Hall Meeting**

The Texas Parks and Wildlife Department is hosting a town hall meeting Monday, March 7, at the Bastrop Convention Center from 6-8 pm, to discuss the independent panel's findings regarding the Rolling Pines Fire. Speakers will include Chief Darryl Jones, South Carolina Forest Protection Chief and team leader of the independent review panel, TPWD Executive Director Carter Smith, Fire Chief for Texas A&M Forest Service Wes Moorehead, as well as state and local elected officials. Once the findings have been shared, the public will have an opportunity to speak. Fire Chief Rosales will be in attendance.

## **Follow-up to February 22 City Council Meeting**

### Citizen Comments from Donald Barron

Development Coordinator, Vivianna Andres, spoke to Donald and Phil (Donald's Project Coordinator), concerning their feedback on the MyGov Portal. They had two major pieces of feedback that asked Vivianna to look into. The first, was the inability to save partial applications on MyGov- Vivi explained that we have asked MyGov to code this into the program on several occasions but that we would continue to send in that feedback until it is hopefully made a reality. The second item concerned which items they believed would be helpful to be included in the knowledge items. Vivi, Allison, and Nicole are working together to add those items to all of the different templates. Mr. Barron said he appreciated the conversation and wanted to thank the City Manager for having someone call him to discuss his concerns.

## **Lost Pines Groundwater Conservation District Public Hearing**

As part of the Simsboro Aquifer Water Treatment Plant, Well Field, and Transmission Facilities Project, the City is required to apply for the following wells drilling and operating permits: Texas Commission on Environmental Quality (TCEQ) and the Lost Pines Groundwater Conservation District (LPGCD).

With the assistance of the Engineer, Freese and Nichols (FNI), we applied for the wells drilling and operating permits to TCEQ and LPGCD for the three water wells. TCEQ granted the permit on November 30, 2021 and LPGCD notified us on February 15, 2022 that the permit was considered administratively complete.

According to LPGCD permitting requirements, once a permit application is considered administratively complete, a public hearing is required. Engineering and Communications staff has been coordinating with LPGCD on scheduling the public hearing at the Bastrop Convention Center for April 4, 2022.

LPGCD has informed the City that they would be mailing notices, with City Engineering staff assisting with that, if necessary, and printing in newspapers in both Lee and Bastrop Counties. People can only protest until five days before the hearing on April 4. If no one protests, then LPGCD can issue the permits within 90 days of the hearing date, and City can decide to move forward with drilling and developing the three wells or wait for the final permit.

Showtime begins at sunset, with many fun activities including oversized games, face painting, community art, light concessions, and plenty of family fun. ### **Upcoming Road Closures on the Hwy 71/Hwy 95 Project**

There will be several lane closures next week. All closures are scheduled from 8:00 pm - 5:00 am.

Tuesday night – Wednesday morning:

The West Bound Outside (Right) Main Lane of SH 71 will be closed from the SH 95 Overpass to just east of the Colorado River Bridge.

The West Bound Frontage Road Inside (Left) Lane will be closed from the UP Rail Crossing to the Colorado River Bridge

Wednesday night - Thursday morning:

The East Bound Outside (Right) Main Lane and the East Bound Frontage Road Inside (Left) Lane will be closed from Hasler Blvd to Childers St.

Thursday night – Friday morning:

The East Bound Outside (Right) Main Lane and the East Bound Frontage Road Inside (Left) Lane will be closed from Childers St to the Colorado River Bridge.

These closures will allow for placement of Large Overhead Sign Supports.

### **Streets and Drainage**

Crews performed saw cuts on Main Street to level up the street for future street improvements.



### **Water/Wastewater**

An Emergency Preparedness Plan (EPP) is a packet of information that an affected utility submits to TCEQ for review and approval. The plan applies to affected utilities and contains information about the water system and how it operates under emergency conditions.

Our Emergency Preparedness Plan (EPP) is complete and was submitted to TCEQ on February 28, 2022.



Unfortunately, we do not have an estimated timeline to expect TCEQ approval/disapproval.

## **Enhanced Cybersecurity Risks**

Last Friday, Governor Abbott [directed](#) the Texas Department of Information Resources (DIR) and the Texas Department of Public Safety (DPS) to use every available resource to safeguard the state's critical infrastructure and to assist local governments in Texas with their needs in response to an enhanced risk for a Russian cyberattack. The governor outlined critical actions that must be taken by DIR and DPS including:

- Enhance Texas' cybersecurity through the use of best industry practices and other key measures
- Ensure Texas can quickly detect a potential cyber intrusion through the use of software services, such as antivirus and endpoint detection and response technologies
- Prepare for an intrusion by utilizing a cyber incident response team
- Maximize the state's resilience to a destructive cyber incident
- Track and report any attacks from Russian sources so the public is fully aware of their tactics

In addition, the Cybersecurity and Infrastructure Security Agency (CISA) guidance is available at [www.cisa.gov/shields-up](http://www.cisa.gov/shields-up). The guidance includes steps cities can take as they implement a

heightened cybersecurity posture, a list of free cybersecurity resources available to critical infrastructure of all sizes, and guidance on how to prepare and mitigate the impact of potential foreign influence operations. DIR has also issued a [press release](#) detailing the rising risks and a list of valuable CISA resources.

During this heightened time, CISA is encouraging all partners to lower their thresholds for reporting potential cyber incidents. If you believe that your city, or a critical infrastructure partner, has experienced a cyber intrusion, please report incidents and anomalous activity to CISA ([Central@cisa.gov](mailto:Central@cisa.gov); 1-888-282-0870) and/or the FBI's 24/7 CyWatch at (855) 292-3937 or [CyWatch@fbi.gov](mailto:CyWatch@fbi.gov).

## **Texas Primary Election Results**

This week, Texans voted in the primary election to select party nominees who will face off in the November general election. The Republican primary resulted in three statewide elected offices that will head into a runoff: attorney general, land commissioner and railroad commissioner. On the Democratic side, four statewide offices will have a runoff: lieutenant governor, attorney general, land commissioner, and comptroller.

## **Texas Comptroller Broadband Listening Tour**

[H.B. 5](#) tasked the comptroller with developing a statewide broadband plan (Plan), among other things. The comptroller is currently developing the Plan, and over the next two months, will host 12 free public forums across the state to hear from Texans about internet access across the state. This information will help the newly established Broadband Development Office (BDO) determine how to close the digital divide in Texas. Linked below are two scheduled forums open for registration.

## **Treasury Releases Updated SLFRF Compliance and Reporting Guidance**

On February 28, 2022, Treasury released updated [Compliance and Reporting Guidance](#) for the State and Local Fiscal Recovery Funds (SLFRF) program. The guidance includes updates to reporting requirements to reflect the SLFRF final rule that Treasury adopted on January 6, 2022. The updated guidance includes two parts. Part 1 contains general guidance related to key principles of the SLFRF program, statutory eligible uses of SLFRF funds, and award terms and conditions. Part 2 provides updated reporting requirements which vary depending on the population of the city receiving the funds and the size of the award. These updates take effect for the next Project and Expenditure Report that all state, local, and Tribal governments must submit by April 30, 2022.

## **SLFRF Grant Update**

Over the past few weeks, TML has reported on the release of the American Rescue Plan Act State and Local Fiscal Recovery Funds (SLFRF) [Final Rule](#) by the U.S. Department of the Treasury and several key differences between the Final Rule and the [Interim Final Rule](#) that was released last year. Earlier updates can be found [here](#) and [here](#). The National League of Cities (NLC) also released guidance in the wake of the Final Rule's release including a list of [10 Things for City Leaders to Know about ARPA SLFRF Grants](#) and analysis of the [allowable water infrastructure projects](#) permitted under the Final Rule.

Of particular interest to many smaller cities is the addition of the “standard allowance” for lost revenue, which was introduced with the Final Rule. TML detailed this change in a previous [Legislative Update article](#), and NLC discusses it in Question 3 of the NLC grant article above, but it bears repeating. If a city chooses the “standard allowance” for lost revenue, the city may use SLFRF funds up to \$10 million to fund “government services,” which the rule says generally includes any service traditionally provided by local governments. Additionally, reporting requirements related to the standard allowance are streamlined when compared to reports required when a city chooses to calculate lost revenue.





Is your family staying in Bastrop during Spring Break? Plan to come to the library for some fun self-directed activities— we've got something for all ages!

### Caldecott winner: *Watercress* by Andrea Wang

The Caldecott recognizes an American illustrator of children's books. Embarrassed about gathering watercress from a roadside ditch in this powerful and moving picture book, a girl learns to appreciate her Chinese heritage after learning why the plant is so important to her parents.

### Newbery winner: *The Last Cuentista* by Donna Barba Higuera

The Newbery is awarded to an American author for distinguished contributions to children's literature.

Petra wanted nothing more than to be a storyteller, like her abuelita. But Petra's world is ending; earth has been destroyed by a comet, and only a few hundred scientists and their children--among them Petra and her family--have been chosen to journey to a new planet. They are the ones who must carry on the human race. Hundreds of years later, Petra wakes to this new planet--and the discovery that she is the only person who remembers earth. **Printz winner: *Firekeeper's Daughter* by Angeline Boulley**

The Printz is based on literary merit and is given to an author of teen books. Daunis has never quite fit in, both in her hometown and on the nearby Ojibwe reservation. As Daunis falls for Jamie, she senses the dashing hockey star is hiding something. Everything comes to light when Daunis witnesses a shocking murder, thrusting her into an FBI investigation of a lethal new drug. Reluctantly, Daunis agrees to go undercover, drawing on her knowledge of chemistry and Ojibwe traditional medicine to track down the source. But the search for truth is more complicated than Daunis imagined, exposing secrets and old scars. As the deceptions--and deaths--keep growing, Daunis must learn what it means to be a strong Anishinaabe kwe (Ojibwe woman) and how far she'll go for her community, even if it tears apart the only world she's ever known. This intricately plotted and candid thriller will be a hit with any reader who likes mysteries.

**Coretta Scott King winner: *Unspeakable: The Tulsa Race Massacre* by Carole Boston Weatherford**

The Coretta Scott King Award recognizes African American authors and illustrators of children's and teen books that demonstrate an appreciation of African American culture and universal human values. This powerful title looks at the Tulsa Race Massacre, one of the worst incidents of racial violence in our nation's history. The book traces the history of African Americans in Tulsa's Greenwood district and chronicles the devastation that occurred in 1921 when a white mob attacked the Black community. News of what happened was largely suppressed, and no official investigation occurred for 75 years. This picture book sensitively introduces young readers to this tragedy and concludes with a call for a better future.
